Vision


WomanACT envisions a world where all women are safe and have access to equal opportunities

Highlights

Research has consistently shown that risk assessment and management is more successful and achieves better outcomes for survivors when a multi-agency approach is adopted. Despite the overwhelming evidence, multi-agency collaboration for high-risk intimate partner violence remains an inconsistent practice across Canada.



A MARAC is a multi-agency meeting that brings together community stakeholders to share information on high-risk domestic violence cases.

In 2019, WomanACT received funding from Women and Gender Equality Canada to test MARAC - a multi-agency high risk domestic violence response - in Canada. MARAC was developed in Wales in 2003 and is now in place in more than 250 communities across the United Kingdom.

WomanACT is working with three communities including Toronto, Perth County and Grey Bruce County to implement, test and evaluate a local and multi-agency high-risk table. The five year initiative is also undertaking research to help adapt the MARAC model to the Canadian context and share the learning and knowledge to support replication across Canada.

Tech for Women's Justice

The research project is looking into the intersections between technology, access to legal information and intimate partner violence.

Our 2020 AGM hosted a panel discussion on the pressing needs of women as a result of the global pandemic and how to ensure a more equitable future.
